

ECE Aid™ is a charitable initiative developed to provide free evaluation reports for vulnerable and displaced international populations.

RECIPIENTS:

525 completed evaluation reports in 2024!

In 2024 ECE Aid™ recipients were educated in Afghanistan, Belarus, Brazil, Burundi, Cameroon, Chad, China, Colombia, Cuba, Democratic Republic of the Congo, Dominican Republic, Egypt, El Salvador, Ethiopia, Ghana, Guatemala, Haiti, India, Iran, Jamaica, Jordan, Kenya, Malawi, Marshall Islands, Mexico, Moldova, Morocco, Nepal, Nigeria, Pakistan, Poland, Russia, Rwanda, South Korea, Spain, Sudan, Switzerland, Tunisia, Türkiye, Uganda, Ukraine, United Kingdom, Venezuela, Vietnam, Zambia, and Zimbabwe.

The top three countries of education were Ukraine, Afghanistan, and Nigeria.

38 new ECE Aid™ participating institutions & organizations joined the program in 2024 to send referrals for fee waivers.



Since 2016 ECE Aid™ has provided fee waivers to recipients from 95 different countries with a total of 1,487 fee waivers completed since the launch of the program.

Guidelines for fee waiver eligibility include, but are not limited to, Temporary Protected Status (TPS), refugee or asylum status, special immigrant status, extreme hardship, or general lack of funds/scholarships due to unavoidable circumstances.


